



Edward Lee Keller

November 30, 1931 - October 10, 2020

Keller, Edward Lee , age 88, of Bruce Township, Michigan died on October 10, 2020 in his home surrounded by family. Ed was one of two sons born to the late George E. and Juanita V. Keller on November 30, 1931 in Pittsburgh, Pennsylvania. His brother, Jack R. Keller predeceased him on May 4, 1974. At a very early age Ed relocated to West Virginia, the home State of his parents where he was raised in the small village of Reedsville. He attended Masontown High school, where he lettered in baseball, basketball and football for each of the three years attended. Following high school, Ed attended West Virginia University, where for two years he participated in the football program. Upon obtaining an AB degree in political science in 1954, Ed enrolled in the West Virginia Law School. After completing his first year of law studies, Ed was called to active duty as a 2nd Lieutenant in the United States Air force at Tyndall Air Force Base in Panama City, Florida. Upon being released from active duty as a 1st Lieutenant in 1957, Ed voluntarily remained in the Air Force Reserve until 1974, achieving the rank of Captain. Following active duty in the Air Force, Ed relocated to Mt. Clemens, Michigan where he enrolled in the Detroit College of Law and obtained an LLB degree in 1959. Desiring to teach law, Ed continued his law studies at the University of Michigan, concentrating on administrative and constitutional law. After accepting a professorship at Chase College of Law in Cincinnati, Ohio, Ed elected to forgo teaching and became a trial lawyer. Following brief employment at the Title Companies, Ed became a Trial Lawyer with the Macomb County Michigan

Prosecutors Office under the late George N. Parris, where he handled several high profile cases until he elected to become associated with the late Frank E. Jeannette in the general practice of law. Upon Frank E. Jeannette becoming a Circuit Judge, Ed relocated his practice to 185 N. Groesbeck, Mt. Clemens, Michigan where he engaged in the general practice of law until retirement in 2015. During his law practice, Ed was proud and privileged to practice with three of his children, Tara, Dena and George and, in addition, by way of association, with Robert Axford, Anthony P. Viviano and his children David and Kathy Viviano.

Since retirement from the practice of law, Ed devoted his time to managing Beacon Cove Marina in Harrison Township along with his partners Earl and Teri Jo Velger and Joan Emerick.

While with the Macomb County Prosecutors office, Ed met and married Carol A. Morris in 1964. Four children were born of the marriage, Dena P. (Joe) Stanley, Nikki R. Keller, Tara K. (John) Gupta and George E. (Carey) Keller. All have chosen careers in law or law related fields. Nikki is a Youth Assistant Supervisor in Oakland County and Dena, Tara and George are attorneys. In addition to the surviving children, there are ten grandchildren, Addison and Jack Stanley, Cameron, Riley and Clayton Fox, Lauren, Charles and Samuel Gupta and Emerson and Kendall Keller.

Professionally, Ed was a member of the Macomb County and State Bar and was authorized to practice in State and Federal Court.

In addition, Ed was a Life Member of the Mt. Clemens AmVets Post 29 and served as its judge advocate in 1962, a member and past President of the Mt. Clemens Old Crowd, a member of the Mt Clemens Juggle Up Club, a Life member of the Sons of Confederate Veterans. Ed belonged to Preston County, West Virginia Lodge #90, of the Ancient Free and Accepted Masons,

and was a 32 degree Member of the Valley of Detroit and a Noble in the Detroit Shriner's.

Being an avid hunter, Ed belonged to and contributed to many hunting and conservation organizations. He was a Life Member of the NRA, a Life Member of Handgun Hunters Museum and Hall of Fame and a Life Member of Safari Club International. Ed was a member of both Novi and Detroit Chapter of the Safari Club International and served as the president of the Detroit Chapter in 1986. Ed served as Director of the American Hand-gunners Association and belonged to and contributed to Ducks Unlimited, North American Deer Foundation and the Mzuri Safari Foundation. Ed's hunting expanded to six continents with trips to Africa (13), England (3), Spain (4), Republic of Kyrgyzstan (2) France, Ireland, Iceland, Canada (9), New Zealand, Scotland Croatia, Serbia, Austria, Argentina (3) Mexico (9) and Alaska (7). The Keller trophy room was published in volume three of Great Hunters. Their Trophy Rooms Collections in 2001 and the Detroit News in 2013. In addition to authoring several articles for hunting magazines, Ed authored and published his Africa adventures in the book, My Africa, in 2017. In 2017, Ed was the recipient of the World Hunting Award Ring, presented to him in Las Vegas, representing the highest and most prestigious honor in the world of hunting.

Aside from his beloved wife of 54 plus years and children and grandchildren, above named, Ed is survived by his dogs Lincoln (Link) and Tango and many close and cherished relatives and friends.
